



FITTING INSTRUCTIONS FOR ECS0127BK ENGINE CASE SLIDER DUCATI MULTISTRADA 1260, 1260S '18- (LEFT HAND SIDE ONLY)



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

Left-hand side (as you sit on bike)

- Remove two M6 bolts that hold the centre cover to the main casing as positioned above, leaving the cover in place.
- Insert new button head screws with washers through slider.
- Offer up to bike.
- Tighten evenly to manufacturer's specified torque.
- Fit bubble sticker as shown above.

**Instructions de montage pour ECS0127 Protection Carter Moteur
DUCATI MULTISTRADA 1260, 1260S '18- (Coté gauche uniquement)**



LA FAÇON DONT LE KIT EST EMBALLE NE CORRESPOND PAS FORCEMENT A LA FAÇON DE MONTER LES PIECES SUR LA MOTO.

Notez que si les kits sont emballés avec des rondelles en caoutchouc servant à tenir les composants, *ces rondelles doivent être jetées.*

Coté gauche assis sur la moto :

- Enlever les 2 boulons qui fixent la protection carter moteur en place, photo ci dessus.
- Si cela n'est pas déjà fait, placez le slider en plastique sur le bloc de métal.
- Enlever le joint torique de la protection d'origine, et logez le dans la rainure circulaire sur le nouveau bloc de métal.
- Insérer les nouveaux boulons avec les rondelles à travers les sliders.
- Monter l'ensemble sur la moto.
- Serrer de façon égale aux couples spécifiques d'usine.
- Mettre les stickers en gomme R&G.
